Purpose

CT LAB (PTY) LTD is a South African based technology company with more than 30 years of practical experience in the field of power quality and distribution monitoring. The company is oriented towards technology development and investing free operating funds in the establishment of technology and new product development. CT LAB offers a unique Power Quality (PQ) solution by providing our customers with unprecedented insight into their electricity networks. With more than 80% of the market share, CT LAB has become the PQ instrument supplier of choice in Southern Africa.

As a company, we understand the need to control environmental risks associated with our work, and to that end we have adopted an ISO 14001 Environmental Management System (EMS) as a tool towards implementing a formal system for managing the associated risks. We follow the Plan Do Check Act (PDCA) model across all key, support and management processes to minimise the negative impact of our work on the environment.

Procedure

Environmental programmes undertaken by CT LAB are:

1. General recycling of paper, metal, glass etc.
2. Recycling of electronic waste, where possible
3. Responsible disposal of electronic waste, especially poisonous or environmentally toxic waste
4. Energy and raw material usage
5. Transport and distribution
6. Reusage of material by repairing faulty devices instead of encouraging clients to buy new ones

CT LAB commits to

1. reduce the impact our work has on the environmental
2. protect the environment and preventing pollution,
3. conform with all our compliance obligations, and
4. continually improve our EMS in order to enhance our environmental performance

CT LAB is committed to meeting environmental requirements from our customers, wherever possible, and commits to provide the necessary resources to achieve it. We encourage further environmental improvements by engaging with our employees.

Objectives relating to environmental performance will be set and reviewed annually by the Environmental Management Team. The company will review all its activities and operations in order to identify and evaluate environmental aspects and impacts, and subsequently undertake actions to address them.

CT LAB seeks to influence all parties in the life cycle of its products and services, and create environmentally friendly ethos amongst its staff, contractors, and suppliers.
